THIS REQUIREMENT IS WAIVED IF THE SELLER HAS AN APPROVED FIRST ARTICLE/CHARACTERISTIC ACCOUNTABILITY PACKAGE ON FILE FOR THE PART NUMBER CONFIGURATION (REVISION LETTER) REFLECTED IN THIS PURCHASE ORDER AND THERE HAS NOT BEEN A LAPSE IN PRODUCTION OF THE PART NUMBER BEYOND THE TIME LIMITS LISTED IN THE MOST CURRENT VERSION OF \$1002.

IF THIS PART, ASSEMBLY OR KIT CONTAINS A PART(S) THAT REQUIRES SOURCE SUBSTANTIATION (SS), THE SELLER WILL FILE EVIDENCE OF SS APPROVAL IN THE FIRST ARTICLE/CHARACTERISTIC ACCOUNTABILITY PACKAGE. IF THE PART(S) IS NOT SS APPROVED, THE SELLER WILL SUBMIT A REQUEST FOR SS REQUIREMENTS TO THE PURCHASER. THE SUPPLIER WILL NOT SHIP ANY SUCH MATERIAL UNTIL SS APPROVAL IS OBTAINED OR WRITTEN APPROVAL FROM THE PURCHASER AUTHORIZES SHIPMENT OF THE UNAPPROVED PART.

A PLANNING VALIDATION PROCESS (PVP) ELECTRONIC TOOL IS AVAILABLE ON THE SUPPLY CHAIN WEB CENTER (SCWC) TO EVALUATE SELLER MANUFACTURING AND QUALITY PLANNING. THE SELLER, AND SELLER'S SUBTIER SUPPLIERS, WILL BE REQUIRED TO CONDUCT PVP ON PARTS WHEN DIRECTED BY THE GE QUALITY REPRESENTATIVE TO ADDRESS SELLER SYSTEMIC QUALITY PROBLEMS, ESCAPES, ETC.

PRODUCTION, ENGINEERING CLASS 'F' AND CLASS 'Y' PARTS (WHEN INDICATED BY SPECIAL 'F' OR 'Y' MARKING ON ORDER) SHALL NOT BE SHIPPED TO ANY GE AVIATION FACILITY, OR ANY OTHER LOCATION SPECIFIED BY GE AVIATION FOR THE FINISHED PART, UNTIL THE FINAL COMPLETE DRAWING IS ISSUED AND AND THE FIRST ARTICLE INSPECTION/CHARACTERISTIC ACCOUNTABILITY IS COMPLETE AND APPROVED UNLESS OTHERWISE SPECIFIED IN THE ORDER AND/OR BY THE GE QUALITY REPRESENTATIVE.
