-LOT OF BATCH NUMBER OF PRODUCT(S) SHIPPED, WHEN APPLICABLE.

-SPECIFICATION NUMBER AND OPERATION DESCRIPTION WHEN PURCHASE ORDER IS FOR SPECIAL PROCESS OPERATIONS ONLY.

THE REMOVABLE BAR CODED SHIPPING LABEL WILL CONTAIN THE FOLLOWING INFORMATION:

-PART NUMBER/SUFFIX AND QUANTITY IN SHIPMENT FOR EVENDALE PRODUCT, OR PART NUMBER/SUFFIX, REVISION LETTER AND QUANTITY IN SHIPMENT FOR LYNN PRODUCT.

-TOTAL BOXES (WHEN MASTER LABELS ARE REQUIRED).

-DOCK NUMBER, PURCHASE ORDER NUMBER, ITEM NUMBER, SUPPLIER CODE, SHIPMENT NUMBER, SUPPLIER NAME AND ADDRESS.

-SPECIFICATION NUMBER AND OPERATION DESCRIPTION WHEN PURCHASE ORDER IS FOR SPECIAL PROCESS OPERATIONS ONLY.

WHEN AUTHORIZED BY PURCHASER TO SHIP MATERIAL ON AN OPEN CASE RECORD, THE CASE RECORD LOT IDENTIFICATION CARD (GT4013) AND A COPY OF THE CASE RECORD WILL BE INCLUDED WITH THE SHIPMENT. ATTACH NON-CONFORMING MATERIAL IDENTIFICATION TAG GT602 TO PARTS OR PACKAGING WHEN SHIPPING TO EVENDALE.
