- 2.) COMSEC NOTICE: ALL COMMUNICATIONS WITH DOD ORGANIZATIONS ARE SUBJECT TO COMMUNICATIONS SECURITY. DOD HAS AUTHORIZED THE MILITARY DEPARTMENTS TO CONDUCT COMSEC MONITORING AND RECORDING OF TELEPHONE CALLS TO AND FROM DOD OGRANIZATIONS. SELLER ASSUMES RESPONSIBILITY FOR ENSURING WIDE AND FREQUENT DISSEMINATION OF THE ABOVE INFORMATION TO ALL EMPLOYEES WHO MAY HAVE DIRECT CONTACT WITH A DOD OFFICIAL.
- 3.) EXPORT CONTROL: EQUIPMENT OR DATA GENERATED OR DELIVERED IN PERFORMANCE OF THE PO IS CONTROLLED BY THE INTERNATIONAL TRAFFIC IN ARMS REGULATIONS, 22 CFR SECTIONS 121-128.
- 4.) MODIFICATIONS TO DATA REQUIREMENTS: FROM TIME TO TIME, THE US GOVERNMENT MAY UNILATERALLY CHANGE (A) THE PLACE OF

DELIVERY, (B) INCREASE OR DECREASE THE NUMBER OF ADDRESSES OR COPIES OF DATA, OR (C) OTHER ADMINISTRATIVE CHANGES OR CLARIFICATIONS TO THE PRIME CONTRACT CDRLS WITH NO ADDITIONAL CHARGE TO THE PO PRICE; PROVIDED THAT THE INCREASE OF DECREASE OF THE NUMBER OF ADDRESSES OR COPIES OF DATA DO NOT EXCEED THE CURRENT REQUIREMENTS BY 50%.

- 5.) PREDETERMINATION OF RIGHTS IN DATA: THE SUPPLIER AGREES THAT ALL DATA FURNISHED BY AND INCORPORATED INTO THE "INDUSTRY VERSION" OF THE FINAL REPORT REQUIRED BY GE AE'S PRIME CONTRACT SHALL BE DELIVERED WITHOUT A RESTRICTIVE RIGHTS LEGEND IN ACCORDANCE WITH DFARS 252.227-7013.

THE SUPPLIER FURTHER AGREES THAT ALL OTHER TECHNICAL DATA REQUIRED BY GE AE'S PRIME CONTRACT SHALL BE FURNISHED WITH GOVERNMENT PURPOSE LICENSE RIGHTS (GPLR); EXCEPT ITEMS, PROCESSES, AND COMPONENTS THAT HAVE BEEN DEVELOPED EXCLUSIVELY AT PRIVATE EXPENSE MAY BE MARKED WITH A RESTRICTIVE LEGEND AS AUTHORIZED IN DFARS 252.227-7013. THE GPLR SHALL REMAIN EFFECTIVE UNTIL THE END OF THE MILLENNIUM AND THEREAFTER THE US GOVERNMENT WILL RETAIN LIMITED RIGHTS ONLY.

- 6.) LIST OF ITEMS DEVELOPED AT PRIVATE EXPENSE: THE LISTING OF ITEMS DEVELOPED AT PRIVATE EXPENSE MAY BE REVISED AS REQUIRED BY AMENDMENT TO THE PO AND PRIME CONTRACT IN ACCORDANCE WITH DFARS 252.227-7013. NOTHING WITHIN THIS ORDER CHANGES, WAIVES OR MODIFIES THE RIGHTS OR OBLIGATIONS OF THE PARTIES UNDER DFARS 252.227-7037.
