

## REQUIREMENT M47

### GOVERNMENT ACQUISITION OF COMMERCIAL ITEMS (FAR PART 12)

**APPLIES ONLY TO: CFM56-2A, -2B, -7B; CF6-50C, -50E, 80C2; GENX-2B**

**THIS IS A PURCHASE OF GOODS THAT MAY BE USED TO FULFILL A US GOVERNMENT CONTRACT. THE FOLLOWING FEDERAL ACQUISITION REGULATION (FAR) and DFARS PART 12 CLAUSES APPLY AS INDICATED:**

- 52.203-12 LIMITATION ON PAYMENTS TO INFLUENCE CERTAIN FEDERAL TRANSACTIONS (Applies when the Order exceeds \$150,000)
- 52.203-13 CONTRACTOR CODE OF BUSINESS ETHICS AND CONDUCT (Applies when the Order exceeds \$5,000,000 and the period of performance exceeds 120 days)
- 52.204-21 BASIC SAFEGUARDING OF CONTRACTOR INFORMATION SYSTEMS (Applies only if Seller is providing an item that is not commercially available off-the-shelf and has federal contract information residing in or passing through its IT system)
  
- 52.219-8 UTILIZATION OF SMALL BUSINESS CONCERNS (Applies when the Order exceeds \$150,000)
- 52.222-50 COMBATTING TRAFFICKING IN PERSONS (Paragraph (h) *Compliance Plan*, applies to any portion of the Order that: (i) is for supplies, other than commercially available off-the-shelf items, acquired outside the United States, or services to be performed outside the United States; and (ii) has an estimated value that exceeds \$500,000))
- 52.222-56 CERTIFICATION REGARDING TRAFFICKING IN PERSONS COMPLIANCE PLAN (Applies if it is possible that at least \$500,000 of the value of the contract may be performed outside the United States and the acquisition is not entirely for commercially available off-the-shelf items)
- 52.244-6 SUBCONTRACTS FOR COMMERCIAL ITEMS
- 52.247-64 PREFERENCE FOR PRIVATELY OWNED U.S. FLAG COMMERCIAL VESSELS (Applies when Goods are to be shipped by ocean vessel unless exempted under paragraph (e)(4))
  
- 252.203-7002 REQUIREMENT TO INFORM EMPLOYEES OF WHISTLEBLOWER RIGHTS (Requires Seller to notify employees in writing, in predominant native language, of whistleblower rights)
- 252.203-7003 AGENCY OFFICE OF THE INSPECTOR GENERAL (As referenced in FAR 52.203-13)
- 252.204-7012 SAFEGUARDING COVERED DEFENSE INFORMATION AND CYBER INCIDENT REPORTING (Applies when Seller has Covered Defense Information resident on or transiting through Seller's unclassified information systems. Seller shall also send to Purchaser all required notifications to the U.S. Government)
- 252.204-7015 DISCLOSURE OF INFORMATION TO LITIGATION SUPPORT CONTRACTORS
  
- 252.222-7007 REPRESENTATION REGARDING COMBATTING TRAFFICKING IN PERSONS (No representation is required other than FAR 52.222-56, if applicable. This clause serves to notify Seller of responsibility to report trafficking in persons at any tier and to protect whistleblowers on trafficking in persons violations from reprisal.)
- 252.223-7008 PROHIBITION OF HEXAVALENT CHROMIUM (Applies when the Order is for supplies, maintenance or repair services)
- 252.225-7028 EXCLUSIONARY POLICIES AND PRACTICES OF FOREIGN GOVERNMENTS
- 252.225-7038 RESTRICTION ON ACQUISITION OF AIR CIRCUIT BREAKERS (Applies if Seller is supplying air circuit breakers)
- 252.244-7000 SUBCONTRACTS FOR COMMERCIAL ITEMS AND COMMERCIAL COMPONENTS (DOD CONTRACTS)
- 252.246-7003 NOTIFICATION OF POTENTIAL SAFETY ISSUES
- 252.246-7007 CONTRACTOR COUNTERFEIT ELECTRONIC PART DETECTION AND AVOIDANCE SYSTEM (Applies only if supplying electronic parts)
- 252.246-7008 SOURCES OF ELECTRONIC PARTS (Applies only if supplying electronic parts)
- 252.247-7023 TRANSPORTATION OF SUPPLIES BY SEA
- 252.247-7024 NOTIFICATION OF TRANSPORTATION OF SUPPLIES BY SEA

- 52.222-37 EMPLOYMENT REPORTS ON VETERANS (Applies when the Order exceeds \$150,000)
- 52.222-40 NOTIFICATION OF EMPLOYEE RIGHTS UNDER THE NATIONAL LABOR RELATIONS ACT (Applies when the Order exceeds \$10,000)
- 252.226-7001 UTILIZATION OF INDIAN ORGANIZATIONS, INDIAN-OWNED ECONOMIC ENTERPRISES, AND NATIVE HAWAIIAN SMALL BUSINESS CONCERNS (Applies the order exceeds \$500,000)
