H-006 RENTAL CHARGES FOR USE OF GOVERNMENT FACILITIES. THIS CLAUSE  
APPLIES IF RENT FREE USE OF GOVERNMENT PROPERTY IS AUTHORIZED.

H-011 FOREIGN CURRENCY EXCHANGE. THIS CLAUSE APPLIES TO EACH  
F-16 PROGRAM SUBCONTRACT INVOLVING USG DIRECTED F-16 COPRODUCTION /  
OFFSET WHICH REQUIRES CURRENCY EXCHANGE.

H-014 HOLD HARMLESS - PATENT INFRINGEMENT IN BELGIUM, THE NETHER-  
LANDS, DENMARK AND NORWAY.

A. THE U.S. GOVERNMENT AGREES TO HOLD HARMLESS THE CONTRACTOR,  
ITS UNITED STATES SUBCONTRACTORS AND SUBCONTRACTORS AT ANY TIER  
LOCATED IN BELGIUM, THE NETHERLANDS, DENMARK OR NORWAY, FROM ANY AND  
ALL LOSS OR LIABILITY AS A RESULT OF INFRINGEMENT OF FOREIGN PATENTS  
OCCASIONED BY EITHER THE USE OR MANUFACTURE OF COMPONENTS OR ITEMS  
PROCURED ON BEHALF OF THE U.S. GOVERNMENT AND THE GOVERNMENTS OF  
BELGIUM, THE NETHERLANDS, DENMARK AND NORWAY.

B. HOWEVER, THE CONTRACTOR AND ANY SUBCONTRACTOR WHO RECEIVES  
THE PROTECTION OF THIS CLAUSE AGREES TO NOTIFY THE GOVERNMENT OF  
ANY KNOWN OR POTENTIAL PATENT INFRINGEMENT CLAIMS AS SOON AS  
POSSIBLE. IN ADDITION, IF A CONTRACTOR OR SUBCONTRACTOR HAS  
INSURANCE PROTECTION COVERING THIS RISK THEN THE PROCEEDS OF THE  
INSURANCE WILL BE PAID TO THE UNITED STATES GOVERNMENT.

H-015 IMPLEMENTATION OF COST ACCOUNTING STANDARDS. APPLIES TO  
EPI SUBCONTRACTS.

H-031 LIMITATION OF LIABILITY. COVERS DAMAGE TO FOREIGN PROPERTY.
